However, the cases we have done are more complex and required a higher number of service hours on average than is typical. The number of people served included recipients of special education advocacy services, vocational advocacy services, and appealing eligibility for state developmental disability services. In addition to providing advocacy services for families who use third party funding or use our sliding fee scale, Bright Horizons staff also served as surrogate parents as prescribed under IDEA, for 34 children in foster care with disabilities in need of evaluation for, or provision of, special education services. Surrogate services are pro bono. Our benefits contractor helped 5 people apply for SSI this year. We do not charge for SSI related advocacy, consistent with SSA guidelines and practices of benefits attorneys. The difference between our practice and that of attorneys is that we do not charge a percentage of benefits awarded.
